

Lease Statistics (The First Half of FY2007)

The lease transaction volume in the first half of FY 2007 (from April 2007 to September 2007) is 3,611.9 billion yen, decreased by 6.3% compared with the same period of the previous year, which is the first time since the first half year of FY 2004 on half the year basis.

With respect to the type of equipment, Construction Equipment (12.1% up) has been on the increase, and Office Equipment (9.4% up) has also kept increasing.

On the other hand, Factory Equipment (5.6% down) and Transport Equipment (4.8% down) have respectively turned to negative growth, which is the first time since the second half of FY 2002. Industrial Equipment (9.3% down) has also turned to negative growth, which is the first time since the second half of FY 2005. Information and Communication Equipment (11.6% down) has been decreasing since the second half of FY2005. Commercial and Service Equipment (10.7% down) and Medical Equipment (15.5% down) have been also on the decrease.

The lease transaction volume in September 2007 is 711.1 billion yen, decreased by 12.1% compared with the same period of the previous year. The volume has been decreasing in a row of 4 months since last June. With respect to the type of equipment, Construction Equipment (10.3% up) has been on the increase. On the other hand, Medical Equipment (20.1% down), Information and Communication Equipment (18.7% down), Transport Equipment (14.7% down), and Commercial and Service Equipment (13.6% down) have showed double-digit decrease respectively. Industrial Equipment (8.1% down), Office Equipment (4.1% down), and Factory Equipment (3.2% down) have also showed negative growth.

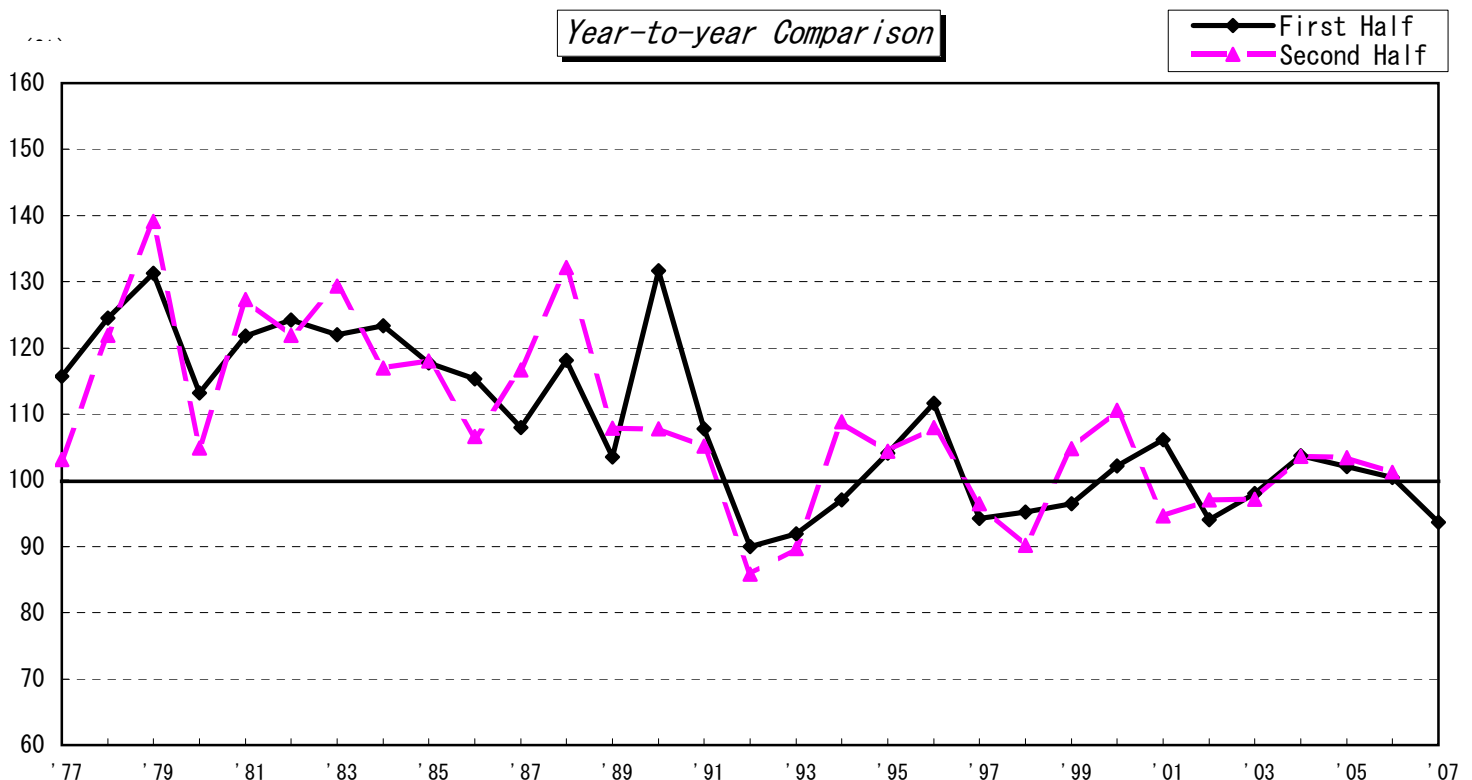

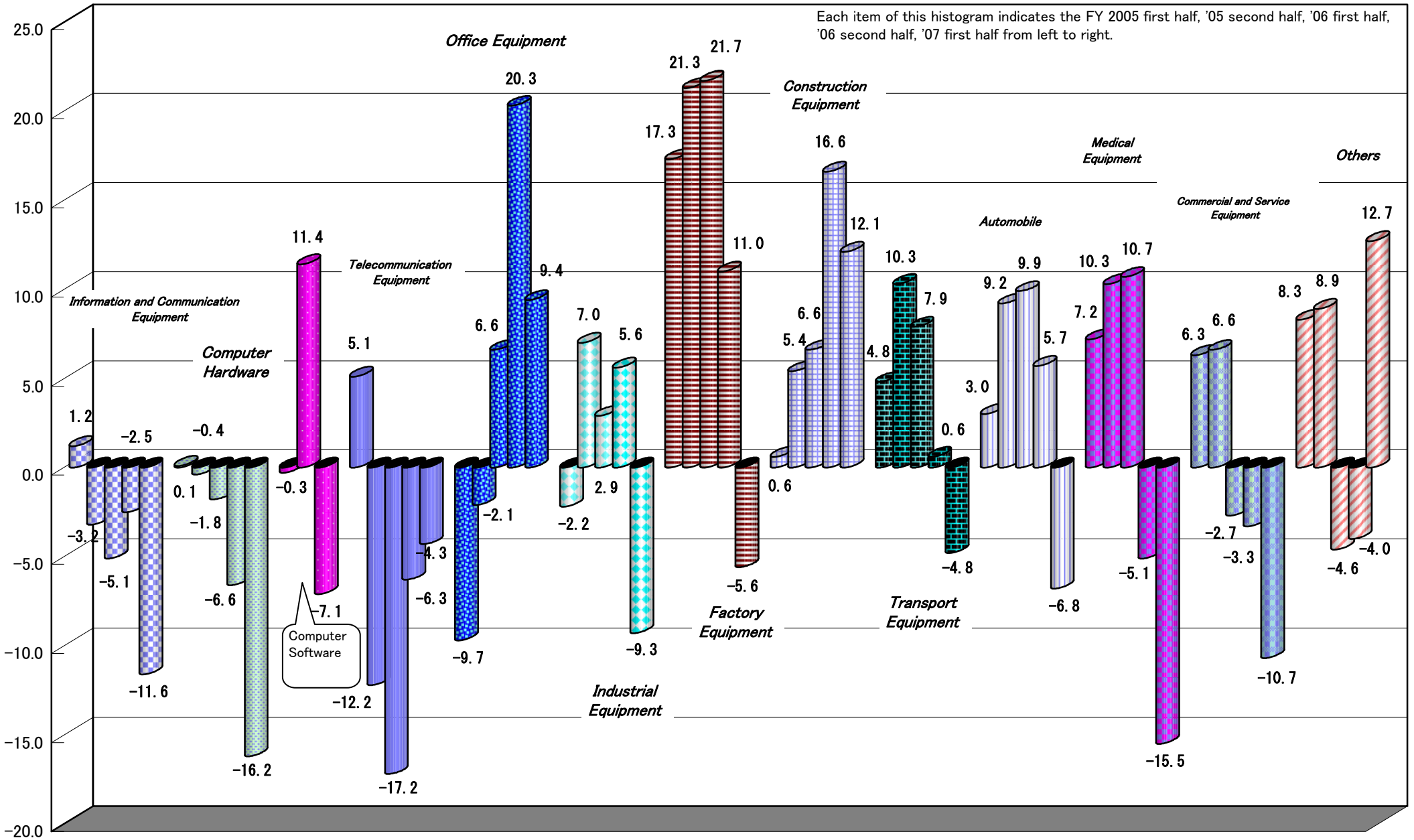
