- Components of total lease transaction volume: "Information and Communication Equipment" increased for the first time in 3 years. "Public Sector and Others" increased in a row of 7 years.
- Leasing capital investment (Consolidated basis): 7,279.4 billion yen, increased by 6.8% compared with FY2017 (Increased by 2.8% for domestic and 26.2% for overseas).

◆ Total Lease Transaction Volume and Leasing Capital Investment

Total lease transaction volume for FY2018 was 5,012.9 billion yen, an increase of 2.8% compared with FY2017; and leasing capital investment was 4,740.3 billion yen, an increase of 2.1% compared with FY2017, total lease transaction volume turned to increase for the first time in 3 years, leasing capital investment turned to increase for the first time in 2 years.

♦ Leasing percentage

Leasing percentage (ratio of leasing capital investment to the total private capital investment) in FY2018 was 5.29%; i.e. approximately over 5% of private capital investments were made through leasing.

• Lease Transaction Volume by Type of Equipment

Information and Communication Equipment (7.3% up), Industrial Equipment (1.7% up), Factory Equipment (6.0% up), Transport Equipment (5.5% up), and Commercial and Service Equipment (2.3% up) had showed positive growth respectively. On the other hand, Office Equipment (2.7% down), Construction Equipment (10.6% down), and Medical Equipment (7.3% down) had showed negative growth respectively.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type

"Small and Medium Sized Companies" (companies with capital of 0.1 billion yen and less or solo proprietors) which accounted for approximately over 50% of total lessees showed a rise (3.7% up) in a row of 2 years. "Large Companies" (companies with capital of over 0.1 billion yen) a rise (1.3% up) for the first time in 6 years. "Public sector and Others" a rise (3.5% up) in a row of 7 years. "Manufacturing" (7.6% up) and "Non-Manufacturing" (1.8% up) had increased for the first time 3 years respectively.

◆ (Reference) Consolidated Lease Statistics (FY2018)

Leasing capital investment for FY2018 on a consolidated basis was 7,279.4 billion yen, an increase of 6.8% compared with FY2017. Components were 5,795.4 billion yen for domestic leasing (2.8% up) and 1,484.0 billion yen for overseas leasing (26.2% up).

Lease Statistics (April 2019)

The lease transaction volume in April 2019 is 443.3 billion yen, increased by 4.4%, compared with the same period of the last year. The lease transaction volume had continued to positive growth in a row 8 months. With regard to the type of equipment, Information and Communication Equipment (14.5% up), Industrial Equipment (21.4% up), Construction Equipment (13.1% up), and Medical Equipment (16.8% up) had showed a double-digit increase respectively. Factory Equipment (0.7% up), Transport Equipment (4.0% up) and Commercial and Service Equipment (0.05% up) had also showed positive growth respectively. On the other hand, Office Equipment (2.4% down) had turned to negative growth for the first time in 3 months.







<Trends in Lease Transaction Volume by Size of Lessee>




<Trends in Lease Transaction Volume by Lessee's Business Type>


