

Lease Statistics (FY2020)

[Key Points]

- Total lease transaction volume: 4,591.0 billion yen, decreased by 13.9% compared with the volume in FY2019.
- Leasing capital investment: 4,290.3 billion yen, decreased by 14.1% compared with FY2019.
- Leasing percentage: 5.06%
- Components of total lease transaction volume: "All Equipment" decreased. "All Size of Lessee" decreased of double-digit.
- Leasing capital investment (Consolidated basis): 6,863.2 billion yen, decreased by 14.2% compared with FY2019 (Decreased by 13.9% for domestic, Decreased by 15.4% for overseas).

◆ Total Lease Transaction Volume and Leasing Capital Investment

Total lease transaction volume for FY2020 was 4,591.0 billion yen, a decrease of 13.9% compared with FY2019; and leasing capital investment was 4,290.3 billion yen, a decrease of 14.1% compared with FY2019, total lease transaction volume and leasing capital investment turned to decrease for the first time for the last 3 years.

◆ Leasing percentage

Leasing percentage (ratio of leasing capital investment to the total private capital investment) in FY2020 was 5.06%; i.e. approximately over 5% of private capital investments were made through leasing.

◆ Lease Transaction Volume by Type of Equipment

Information and Communication Equipment (13.8% down), Office Equipment (3.7% down), Industrial Equipment (15.6% down), Factory Equipment (20.7% down), Construction Equipment (0.9% down), Transport Equipment (11.9% down), Medical Equipment (11.4% down), and Commercial and Service Equipment (20.2% down) had showed negative growth all the types of equipment.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type

"Small and Medium Sized Companies" (companies with capital of 0.1 billion yen and less or solo proprietors) which accounted for approximately 50% of total lessees showed a declined (13.7% down) for the first time for the last 4 years. "Large Companies" (companies with capital of over 0.1 billion yen) a declined (13.6% down) for the first time for the last 3 years. "Public sector and Others" a declined (15.6% down) for the first time for the last 9 years. "Manufacturing" (21.8% down) and "Non-Manufacturing" (14.2% down) had decreased for the first time for the last 3 years respectively.

◆ (Reference) Consolidated Lease Statistics (FY2020)

Leasing capital investment for FY2020 on a consolidated basis was 6,863.2 billion yen, a decrease of 14.2% compared with FY2019. Components were 5,617.5 billion yen for domestic leasing (13.9% down) and 1,245.7 billion yen for overseas leasing (15.4% down).

Lease Statistics (April 2021)

The lease transaction volume in April 2021 is 376.6 billion yen, decreased by 10.7%, compared with the same period of the last year. The lease transaction volume had continued to negative growth in a row 5 months. With regard to the type of equipment, Office Equipment (14.3% up) had continued to positive growth in a row of 7 months. On the other hand, Information and Communication Equipment (14.6% down), Industrial Equipment (1.8% down), Factory Equipment (21.6% down), Construction Equipment (4.9% down), Transport Equipment (0.2% down), Medical Equipment (14.5% down), and Commercial and Service Equipment (12.2% down) had showed decreased respectively.











Trends in Lease Transaction Volume by Size of Lessee and Lessee's Business Type

<Trends in Lease Transaction Volume by Size of Lessee>




<Trends in Lease Transaction Volume by Lessee's Business Type>



- Information and Communication Equipment (14.6% down), Industrial Equipment (1.8% down), Factory Equipment (21.6% down), Construction Equipment (4.9% down), Transport Equipment (0.2% down), Medical Equipment (14.5% down), Commercial and Service Equipment (12.2% down) decreased.
