

Lease Statistics (FY2022)

[Key Points]

- Total lease transaction volume: 4,310.6 billion yen, increased by 2.2% compared with the volume in FY2021.
- Leasing capital investment: 4,034.7 billion yen, increased by 1.8% compared with the volume in FY2021.
- Leasing percentage: 4.18%
- Components of total lease transaction volume: "Industrial Equipment" and "Medical Equipment" double-digit increased. "Large Companies" and "Small and Medium Sized Companies" increased for the first time for the last 3 years.
- Leasing capital investment (Consolidated basis): 8,353.4 billion yen, increased by 12.0% compared with FY2021 (Increased by 2.4% for domestic, Increased by 40.7% for overseas).

◆ Total Lease Transaction Volume and Leasing Capital Investment

Total lease transaction volume for FY2022 was 4,310.6 billion yen, a increase of 2.2% compared with FY2021; and leasing capital investment was 4,034.7 billion yen, a increase of 1.8% compared with FY2021, total lease transaction volume and leasing capital investment showed increase for the first time for the last 3 years.

◆ Leasing percentage

Leasing percentage (ratio of leasing capital investment to the total private capital investment) in FY2022 was 4.18%; i.e. approximately 4% of private capital investments were made through leasing.

◆ Lease Transaction Volume by Type of Equipment

Industrial Equipment (10.8% up), and Medical Equipment (10.8% up) had showed double-digit increase. Office Equipment (5.6% up), and Commercial and Service Equipment (9.6% up) had also showed positive growth. On the other hand, Information and Communication Equipment (2.1% down), Factory Equipment (1.9% down), Construction Equipment (0.4% down), and Transport Equipment (2.0% down) had continuously showed negative growth.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type

"Small and Medium Sized Companies" (companies with capital of 0.1 billion yen and less or solo proprietors) which accounted for approximately 50% of total lessees showed a rise (4.7% up) for the first time for the 3 years. "Large Companies" (companies with capital of over 0.1 billion yen) a rise (6.9% up) for the first time for the 3 years. "Public sector and Others" showed a declined (19.0% down) for the first time for the last 2 years.

"Manufacturing" (7.9% up) and "Non-Manufacturing" (2.1% up) had increased for the first time for the 3 years respectively.

◆ (Reference) Consolidated Lease Statistics (FY2022)

Leasing capital investment for FY2022 on a consolidated basis was 8,353.4 billion yen, an increase of 12.0% compared with FY2021. Components were 5,741.9 billion yen for domestic leasing (2.4% up) and 2,611.5 billion yen for overseas leasing (40.7% up).

Lease Statistics (April 2023)

The lease transaction volume in April 2023 is 357.9 billion yen, decreased by 5.2%, compared with the same period of the last year. The lease transaction volume had turned to decrease for the first time for the last 3 months. With regard to the type of equipment, Industrial Equipment (0.8% up), Construction Equipment (6.9% up), Transport Equipment (0.1% up), and Medical Equipment (7.4% up) had showed increased respectively. On the other hand, Information and Communication Equipment (2.1% down), Office Equipment (5.8% down), Factory Equipment (14.4% down), and Commercial and Service Equipment (6.4% down) had showed decreased respectively.



※Total Private Capital Investment, based upon nominal value, is researched by Cabinet Office. The statistic in FY 2022 is preliminary.








Trends in Lease Transaction Volume by Size of Lessee and Lessee's Business Type

<Trends in Lease Transaction Volume by Size of Lessee>




<Trends in Lease Transaction Volume by Lessee's Business Type>



Lease Statistics (Apr.2023)

(Overview)

- The lease transaction volume in April 2023 is 357.9 billion yen, decreased by 5.2%, and decreased for the first time for the last 3 months.
- Industrial Equipment (0.8% up), Construction Equipment (6.9% up), Transport Equipment (0.1% up), Medical Equipment (7.4% up) increased.
- Information and Communication Equipment (2.1% down), Office Equipment (5.8% down), Factory Equipment (14.4% down), Commercial and Service Equipment (6.4% down) decreased.
